# JUNE PULPIT POST

## “Your Advantage?”

***“Nevertheless, I tell you the truth: it is to your advantage that I go away, for if I do not go away, the Advocate will not come to you; but if I go, I will send him to you.”***

**John 16:7**

As the month of June begins, Pentecost, the longest season of the church year, is in full swing. This season is also called “ordinary time” since there is a long stretch of Sundays before the next big day in the church year. However, the season of Pentecost is anything but ordinary. Jesus calls the time when He ascends to heaven and His Father sends us the Holy Spirit as “our advantage”.

What could possibly be helpful for us by Jesus going back to his Father in heaven? Jesus tells us that when He returns to heaven, he will not leave us abandoned. In fact, Jesus becomes more accessible than when he walked on the earth. Jesus said that the Advocate, the Holy Spirit, the Comforter, or His Helper would not come without his return to heaven. On Pentecost, the Holy Spirit arrived and has been with us ever since calling and gathering Christians together and delivering comfort to troubled souls to places that Jesus never traveled.

As this “ordinary” time of Pentecost begins, we also welcome a return of some “ordinariness” in our communities and churches. There is an advantage to attending graduation receptions in person compared to waving to graduates from a distance as they parade through streets. There is an advantage for families to gather in person to celebrate important family events. There is an advantage for families to gather for a reception following a funeral for a time of fellowship. And there is an advantage to worshipping in person compared to watching and listening to an online worship. There is an advantage in the ordinary.

The Holy Spirit who came to us at Pentecost and who is forever with us has led us through a difficult time of pandemic. It is good for many aspects of life returning to a sense of what we remember as ordinary. Our church doors are again open wide for you to hear the extraordinary promises the Lord has for you.

# Parish Nurse & Health Board

With the month of June comes summer. Seems like we have been waiting for it for a while, so now time to enjoy, but this does not eliminate the depression and anxiety that has come out of the epidemic with so many people not being able to meet in person.

Depression and anxiety disorders are related, but also different from each other. They can take many forms and usually do not just go away.

Typically there is something that will trigger mental illness and there is no shame in seeking treatment options. People do not go through depression the same way. Shutting out people, stopping doing things used to enjoy, finding it hard to focus or think. Other things may be feelings of sadness that does not go away; feeling anxious or extremely guilty about past or present events; changes in eating habits, sleep or personal care; new or increased alcohol or drug use; having a negative view of yourself or others; failure or being a burden to others and would be better off dead. Any thought of suicide should be taken very seriously and will need to seek immediate help. Older adults with depression may not feel sad. They often report anxiety, physical aches and pains, memory loss, or difficulty with maintain clear thought process. Depression is very common in people with diseases affecting the brain, such as people with Parkinson's disease or have had a stroke.

Anxiety: a normal response to life's challenges or major decision and for people with an anxiety disorder, the worries and distress don't go away easily. They may even be so severe that daily activities and relationships can be disrupted. A panic disorder involves a panic attack which comes on suddenly with intense, unexpected fear and can have symptoms of a pounding heart or racing heart, sweating, shaking and a feeling of impending doom.

Treating a mental illness such as depression or anxiety disorder comes with a lot of issues that may take multiple tries in finding a treatment plan or combination that fits the person best. No matter how things are going, it is very important to communicate regularly with members of the health care team and adjust treatments as needed as without patient input, the team cannot help as well. Always sticking with the medications prescribed are very important but may take up to 4-8 weeks to feel a noticeable difference.

Anyone with symptoms of depression or anxiety disorder should get help. Negative comments are changing and no one should be ashamed about seeking care for mental health. People should start by talking to their health care provider and can start as simple as saying you don't feel like yourself lately. Provider may want to rule out other causes for the symptoms such as medication side effects or a thyroid disorder, but when all is normal may recommend counseling or medication and will follow in the care.

As mentioned earlier, pandemic conditions such as isolation have been very difficult for some people and getting care needed will be very beneficial.

## April 12, 2021

The monthly meeting of the Baltic Lutheran Church Council was held at Baltic Lutheran Church on April 12, 2021. Pastor Randall Questad and Marjell Wendland were also present. Not present: Alana Tommeraasen and J. Serna.

Dale Erickson called the meeting to order.

Pastor Randall gave the opening prayer.

Motion by Al VanEck and second by John Sinding to approve the March minutes. Motion carried.

### **Financial Report:**

Myron Nohava made a motion to move the \$1,000 from technology grant out of the expense account to technology fund. Second by Al VanEck, motion carried.

### **New Business:**

# East Nidaros Council Minutes

## April 5, 2021

**Present:** Kathy Hegge, Jesse Hartman, Pastor Randall Questad, David Daugaard, Alvina Harvey, Jimmie Vollan, Craig Krogstad  
Craig Krogstad called the meeting to order.

**Secretary minutes:** Emailed out prior to the meeting by Kathy Hegge. A motion to accept the minutes as emailed was made by Jesse Hartman and seconded by Alvina Harvey.

**Financial Reports:** February and March reports were handed out at the meeting. Check has been received from the SD Synod for the grant that Kathy Hegge applied for and they have asked that we provide written and pictorial documentation to be submitted to them by next January. We have received another anonymous donation of corn. Kathy has applied for Forgiveness of the first PPP loan, and First Premier has approved it. It has been fully approved by the State. We will not owe that first loan amount back. A motion to accept the report as presented was made by David Daugaard and seconded by Jimmie Vollan.

**Parish Nursing report:** Marjell Wendland provided an update on the foot care clinic. There is a great need for this program. She stated there is a waiting list of people who need foot care.

The Health Board meeting suggested opening up fellowship prior to church and it would be up to the individuals who feel comfortable partaking in the fellowship. Phase 3 was also brought up if they could start that again. A question was made if there is a copy of the contract for the Parish Nursing program. Marjell stated she has a copy and she will provide that to the secretary to include in the minutes.

**Pastor Report:** The last week was pretty busy leading up to Easter. Confirmation is coming up on Mother's Day and senior recognition also. April 18th and May 16th Ellen will be gone and we will have alternates for the organ. There are a couple of Baptisms coming up for the summer. And Pastor has 5 weddings coming up this summer. Bible Study has been restarted and will begin in Baltic due to the painting at East. Pastor asked how everyone felt about the Lenten services. It was less attended this year. The feeling was that it has a lot of value even if it isn't well attended. Sunrise service was well attended and we are hoping to be able to offer Easter Breakfast again next year. There's a program that was brought up to Pastor this week called the Moses project that is specific to rural ministry and is a good way for Pastor to connect with other *Cont.*

pastors that are in rural communities. The program begins in August and it ends in May. Pastor asked for ideas and suggestions that we would like him to look into that are specific to rural ministry needs.

### **Old Business:**

Memorial Day service is on track to happen this year.

Painting will start on April 12th. Everything needs to be off the walls this week and weekend. Saturday morning at 9am work day for those who can help.

### **New Business:**

Discussion was had around the library and what to do with the library. Tabled at this time.

Motion to hire a carpet cleaner during the painting, motion was made by Alvina Harvey and David Daugaard seconded the motion. Motion passed. Trustees to look into hiring that out.

Mid-State was out again to look at options for wires. Kathy to follow up with them again. There was miscommunication as to what was needed/wanted.

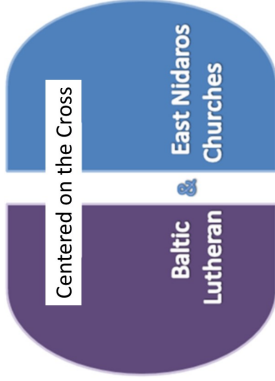
